## 1. Introduction

The following terms and conditions (“Terms of Use”) govern the use by you of our websites, online services, communications, materials, content, media, and any other features we provide (“Services”).

BY USING OUR SERVICES, YOU AGREE TO ABIDE BY THESE TERMS OF USE AND OTHER REFERENCED POLICIES AND/OR CONDITIONS.

## 2. Parents’ responsibility

For children under the age of 13, a parent or legal guardian may permit their child to use our services under the parent’s / legal guardian’s supervision. It is the responsibility of the parent / legal guardian to ensure that any children under their care comply with these Term of Use. The parent / legal guardian is at all times responsible for the conduct of their child on our services, including any content submitted by them to our services.

## 3. Commercial use prohibited

Our services are for you or your child’s personal use only. You shall not exploit our services for any commercial purpose, nor use our services in a manner that does not comply with these Terms of Use.

## 4. Your legal obligations

By using or allowing children under your care to use our services, you agree to abide by the laws set by the government of the United Kingdom of Great Britain. You further agree not to use or allow our services to promote hatred, defamation, racism, sexism, violence, indecency, obscenity, illegal acts, or breach any form of copyright or trademark laws.

All intellectual property and content provided through our services is protected by the trademark, copyright and intellectual property laws of the United Kingdom of Great Britain and other countries intellectual property laws. As such it is prohibited to copy, reproduce, distribute, exhibit, or modify in any way (in whole or part) any text, image, video, music or sound. Any violations of the applicable trademark, copyright and/or intellectual property laws may give

rise to legal proceedings, which are under all circumstances to be conducted under the law of the United Kingdom of Great Britain.

## **5. Communications**

As per our Privacy Policy, we retain the e-mail address of anyone who submits content to our services (parental / legal guardian e-mail for children under 13), or requests to be added to a mailing list. We will communicate with users by e-mail where we have the need to inform them of update to the website (the mailing list), or to provide necessary service statements and updates. We will only share e-mail addresses with law enforcement agencies upon receiving a legitimate request.

## **6. Prohibition against rogue content**

It is prohibited to attempt to submit any content that contains any media or software that contains a computer virus, trojan horse, timebomb, worm, or any other rogue content. If any such material is detected in submissions, the offending user will be reported to the appropriate legal authorities along with the provider of their email address.

We take all precautions to prevent rogue content from our own sources or from our users. However, you agree that any content or media downloaded from our services is at your own risk, and you are advised to ensure you have adequate precautions in place to minimise any loss or corruption of your own files, by use of anti-virus software and sufficient file backups. Therefore you agree we cannot be held responsible in any way for any damages or losses caused by rogue content downloaded from our services.

## **7. Content you submit to us**

You are responsible for any content submitted to us by yourself, or on behalf of your child where they are under 13 years of age. Unless otherwise stated, we are under no obligation to monitor the content you submit to us for its use or misuse by third parties.

By submitting any content to us, you agree to provide it free from any trademark, copyright or intellectual property infringements, and that if such an issue is brought to our attention, that you are solely responsible for rectifying the issue. With such issues when we are notified, we will remove the relevant content from our services at our discretion until the issue is resolved, or replacement content is provided. Any user who is found to be repeatedly attempting to submit content which is either unsuitable for our services, or repeatedly infringes trademark, copyright or intellectual property laws may be subject to a suspension or ban from using our services.

We review and moderate any content submitted to us. We withhold the right to refuse to publish any content which we feel does not comply with our principles and policies.

By submitting content to us, you agree to grant us with a perpetual, sublicensable, non-exclusive, royalty-free, worldwide licence to transmit, copy and display such content in any and all media we use as part of our services or to advertise our services, with the provision that you have the necessary rights to provide your content to us under the stated licencing terms.

Our services are provided on an “as is” basis without warranties of any kind, either express or implied, including without limitation warranties of title, non-infringement, or implied warranties of merchantability or fitness for a particular purpose.
